SATISO SEKUTFUTFUKISWA KWE NDZAWO YA KABOKWENI KANYE NENDZAWO YASE BARBERTON

CITY OF MBOMBELA MUNICIPALITY

Umkhandu-dolobha weCity of Mbombela watisa bonkhe bantfu ngekwakhiwa kweluhlelo-mgomomo lwemkhandlu lokukutfutfukakiswa kwendzawo yase Barberton kanye nendzawo ya KaBokweni ngekulungiswa kwe Barberton Precinct Plan kanye ne KaBokweni Precinct Plan. Lesatiso sikhishwa ngekuhambisana nesigaba 21 (1) (a) ngekwemtsetfo we Tinhlelo taMasipala (Municipal Systems Act, 2000 (Act 32 of 2000).

I'Spatial Planning and Land Use Management Act, 2013' (SPLUMA), ngaphansi kweNcenye E, Sahluko 4, ichaza lokufanele kucuketfwe kuleLuhlelo-mgomomo lekutfutfukiswa kwetindzawo taMasipala (MSDF). Sigatjana (I) sichaza kutsi i-MSDF kufanele "ikhombise tindzawo letikhetsiwe lapho - (i) kutawakhiwa luhlelo lwendzawo lelicuketse imininingwane lengetiwe". Ema 'Precinct Plans' ngulenye yetindlela tekutfutfukisa luhlelo lwendzawo ngoba acuketse umniningwane longetiwe mayelana nalendzawo lekhetsiwe.

Loluhlelo-mgomomo lwekuftuftukiswa kwendzawo yaKabokweni kanye nendzawo yase Barberton lubeka umbono wendlela yentutfuko yesikhatsi lesitako ngekusungula indlela yekuhlela nekuphatsa lecondzisa intutfuko nekugucugucuka kweku setjentiswa kwemhlaba. Loluhlelo luhlose kuphumelelisa tenhlalakahle, temnotfo netemvelo. Loluhlelo litawuphindze livete tindlela tekungenelela letidzingekako esikhatsini lesifishane kuya eskhatsini lesiluliwe kute lugcugcutele kututfukisa lendzawo nekuhlanganiswa kwetindawo letihlanganiswe ngekwetemnotfo, letihehako, letisebenta kahle, letiphephile tiphindze tilawuleke kahle. Loluhlelo lwekulungiswa kwe-Barberton kanye ne-Kabokweni Precinct Plans ludzinga kuLanganyela nemphakatsi kute kutfolakale imibono nobe kuphawula lokuvela emphakatsini.
