- \* The Mpumalanga Gospel Music Awards are only open to all Gospel Artist, Recording Companies, Engineers, Producers and Promoters that are based in Mpumalanga Province and have valid South African Identity Documents.
- \* All entrants and/or nominees must have atleast a 10 Track Album for their entries of Category A.
- \* Entrants of category B may be allowed to enter if they have a 10 track album and such an album is more than 6 months

### GENERAL RULES:

1. No late entry will be considered beyond 12h00 pm (midnight) on the closing date of the nomination period.
2. The Judge's and the selection Committee's decision shall be considered as final.
3. The Mpumalanga Gospel Music Awards shall accept no responsibility for any gramatical, incorrect filling of forms or any other typographical errors on any nominee's form lodged for the MGOMA Awards.
4. The MGOMA Advisory Board may at any given stage of the competition ammend through a Board Resolution any rule or procedure for the benefit of the Awards.
5. Nominee's will be accepted in line with the rules after filling in a nomination form which can be downloaded or collected from our Nelspruit Office or collected from any community Radio Stations in the Mpumalanga Province.
6. All entrance hereby cede and agrees to all rules and conditions here in set by MGOMA and Futher Authorise MGOMA to use their Photographs, Names, Biography and any submitted materials to chieve the following:
